PRIVACY POLICY OF ALL COMPANIES AND ENTITIES OF THE FERREYCORP CORPORATION

Compliance with the Peruvian Personal Data Protection Law is very important for FORBIS LOGISTICS S.A., a subsidiary of Ferreycorp S.A.A., hereinafter referred to as (Forbis Logistics), and, in general, for all companies and entities of the Ferreycorp Corporation (Ferreycorp S.A.A., its subsidiaries, the subsidiaries of the latter, the companies in which Ferreycorp S.A.A. is a shareholder, and its related entities). This regulation establishes that in order to process the data or information of a natural person, their prior, informed, express, and unequivocal consent is required. In the case of sensitive data processing, written consent is also required. For this reason, in the use of digital networks and in compliance with the aforementioned law, Forbis Logistics and the other companies and entities of the Ferreycorp Corporation will consider that you have adequately provided your consent when you positively choose to "click," "tap," "touch," or use similar actions when asked for your acceptance of the applicable terms for the processing of your personal data.

You can trust that Forbis Logistics and the other companies and entities of the Ferreycorp Corporation have implemented all necessary technical and organizational measures to ensure the security and confidentiality of your personal information, and to prevent any improper manipulation, accidental loss, destruction, or unauthorized access by third parties to this information, using appropriate means to counteract such risks.

1. THE INFORMATION WE COLLECT THROUGH OUR WEBSITES

We only collect the personal data that you wish to provide to us or that is necessary to offer (and improve) our products and services, and for the purposes described in point 3 of these terms, which you freely accept. We collect direct personal information such as name, ID number, address, phone number, email; information expressly indicated on our websites through electronic forms or other formats; information you provide to us directly or indirectly, such as cookies (information about user preferences when visiting a website), connections, and information systems; all of this in strict compliance with the Personal Data Protection Law.

2. WE STORE YOUR INFORMATION SECURELY

You can trust that Forbis Logistics and the other companies and entities of the Ferreycorp Corporation have implemented all necessary technical and organizational measures to ensure the security and confidentiality of your personal information. Only authorized personnel from Forbis Logistics and the other companies and entities of the Ferreycorp Corporation, as well as third parties with whom we maintain a contractual relationship (for example, service providers or clients), will have access to and process your personal information, provided they commit to respecting this Privacy Policy and data protection regulations. All authorized individuals who are not part of Forbis Logistics and who have access to your personal data will do so in compliance with the terms established in the applicable legislation regarding the processing of your personal data.



3. PURPOSES OF THE PROCESSING OF YOUR PERSONAL DATA

The personal data that you freely provide through the websites of Forbis Logistics and the other companies of the Ferreycorp Corporation will be processed for the following purposes: addressing inquiries or claims and following up on them; sending information or advertising about the products and services of all companies and entities of the Ferreycorp Corporation; inviting you to participate in our seminars, training sessions, workshops, contests, surveys, and other activities or events; registering you in the Forbis Logistics Operators Club or another similar program developed by Forbis Logistics or the other companies and entities of the Ferreycorp Corporation; internal management and administration of our customer list, market studies, or commercial or statistical research; carrying out billing processes; e-commerce; managing your application for a current or future vacancy at Forbis Logistics or another company or entity of the Ferreycorp Corporation; conducting evaluations for granting credit, updating or verifying your information; or as a reference source. Your data will also be used to manage, support, and obtain information about the quality of our products and services, and to prevent breaches (disruptions) of our security, the law, and contractual terms. Considering the purposes described and the fact that sometimes the processing of your information corresponds to the fulfillment of legal obligations, you grant your consent indefinitely. If you do not agree with the subsequent processing of your information, you may proceed as indicated in section 5.

By consenting to the processing of your personal data, you declare that this consent will prevail over any registration in the "Thank you... do not insist" registry of Indecopi, its replacement, or any blocking list for sending communications. This does not prevent your right to delete your personal data or revoke your consent at any time.

4. ACCESS AND TRANSFER

Forbis Logistics will never share your personal data with third parties for purposes other than those you have consented to. Forbis Logistics may share your personal information with other companies and entities that are part of the Ferreycorp Corporation for the purposes you have consented to. Forbis Logistics may also share your personal data with third parties, which may be located within or outside the national territory, but only under strictly limited circumstances, as outlined below:

We may provide your personal data to third parties (such as our internet service providers, website administrators, social media account managers, call centers, messaging services, transportation providers, seminar or training organizers, clients, etc.) who assist us in maintaining and managing this or other websites of Forbis Logistics and/or other companies and/or entities of the Ferreycorp Corporation (including but not limited to the pages and accounts that Forbis Logistics maintains on social media). These third parties may be located in a territory other than the national one.

We may also disclose your personal data to public administration bodies and competent authorities if we are required to do so under legal obligations. In some cases, we must also provide your personal information to the aforementioned entities for the development of a legal, judicial, and/or administrative process; to respond to any claim or demand; or to protect the legitimate rights of the companies and entities of the Ferreycorp Corporation, their clients, and any other user.

In exceptional situations, it may be necessary for us to provide your personal information to potential buyers of any business line or company within the Ferreycorp Corporation. You can be assured that this will only occur in cases where there is a confidentiality agreement regarding the processing of your personal information and respecting the purposes for which you have consented to the processing of your data.

5. EXERCISE OF YOUR RIGHTS AS A DATA SUBJECT

Forbis Logistics uses tracking technology ("Cookies") to collect personal information, such as browser type and operating system, referral page, navigation through the site, ISP domain, among others, in order to understand how visitors use Forbis Logistics' websites. The use of cookies helps us design this website to meet your needs. All cookie information is stored by Forbis Logistics in formats that do not allow the identification of its owner. Notwithstanding this, such information will not be shared with third parties and will not be used for sending unsolicited communications.
