# PRIVACY POLICY OF ALL COMPANIES AND ENTITIES OF THE FERREYCORP CORPORATION

Compliance with the Peruvian Personal Data Protection Law is very important to FORBIS LOGISTICS S.A., with registered office at Av. Elmer Faucett 2823, Building A, Office 504, Callao District, Province and Department of Callao, a subsidiary of Ferreycorp S.A.A., hereinafter (Forbis Logistics), and, in general, to all companies and entities of the Ferreycorp corporation (Ferreycorp S.A.A., its companies and all subsidiaries, the subsidiaries of the latter, the companies in which Ferreycorp S.A.A. is a shareholder, and their related entities, details of which can be found on the website www.ferreycorp.com.pe). This regulation establishes that, in order to process the data or information of a natural person, their prior, informed, express, and unequivocal consent is required. In the case of processing sensitive data, written consent is also required. For this reason, when using digital networks and in compliance with the aforementioned law, Forbis Logistics and the other companies and entities of the Ferreycorp corporation will consider that you have adequately provided your consent when you positively "click," "tap," "tap," or "tap" or other similar actions when asked to accept these terms applicable to the processing of your personal data. These data will be stored indefinitely or until your consent is revoked.

You can trust that Forbis Logistics and the other companies and entities of the Ferreycorp corporation have adopted all necessary legal, technical, and organizational measures to guarantee the security and confidentiality of your personal information and to prevent any improper manipulation, accidental loss, destruction, or unauthorized access by third parties to this information, employing appropriate means to counteract them.

#### 1. THE INFORMATION WE COLLECT THROUGH OUR WEBSITES

We only collect personal data that you choose to provide or that is necessary to provide (and improve) our products and services, and for the purposes described in Section 3 of these terms and which you freely accept. We collect direct personal information such as name, ID number, address, telephone number, and email address; information expressly provided on our websites through electronic forms or other formats; information that you provide and authorize directly or indirectly, such as cookies (information about user preferences when visiting a website), connections, and information systems; all in strict compliance with the Personal Data Protection Law.

#### 2. WE STORE YOUR INFORMATION SECURELY

You can trust that Forbis Logistics and the other companies and entities of the Ferreycorp Corporation have adopted all necessary legal, technical, and organizational measures to guarantee the security and confidentiality of your personal information. Only authorized personnel from Forbis Logistics and the other companies and entities of the Ferreycorp Corporation, and third parties with whom we maintain a contractual relationship (for example, service providers or clients), may access and process your personal information, provided they agree to comply with this Privacy Policy and data protection regulations. All authorized persons outside of Forbis Logistics who have access to your personal data will do so in compliance with the terms established in the legislation applicable to the processing of your personal data.

#### 3. PURPOSES OF THE PROCESSING OF YOUR PERSONAL DATA

The personal data you freely provide through the websites of Forbis Logistics and other companies of the Ferreycorp Corporation will be processed for the following purposes: to respond to inquiries or complaints and follow up on them; if you provide your consent, to send information or advertising about the products and services of all companies and entities of the Ferreycorp Corporation; if you provide your consent, to invite you to participate in our seminars, training sessions, workshops, contests, surveys, among other activities or events; to enroll you in any program developed by Forbis Logistics or other companies and entities of the Ferreycorp Corporation; to manage and internally administer our client list, market research, or commercial or statistical research; to carry out billing processes and record payment vouchers in general, whether from suppliers, customers, or others; if you provide your consent, to use electronic commerce; to manage your application for a current or future vacancy at Forbis Logistics or another company or entity of the Ferreycorp Corporation; to carry out evaluations for the granting of credit, update or verify your information; or as a reference source. Your data will also be used to manage, support, and gather information about the quality of our products and services, and to prevent breaches (tampering) with our security, the law, and contractual terms. Considering the purposes described and that the processing of your information sometimes corresponds to compliance with legal obligations, you grant your consent indefinitely. If you do not agree to the further processing of your information, you may proceed as indicated in Section 5.

By giving your consent to the processing of your personal data, you declare that this consent will prevail over any registration in Indecopi's "Thank you... don't insist" registry, any registry that replaces it, or any blocking list for sending communications. This does not impede your right to delete your personal data or revoke your consent at any time.

### **4. ACCESS AND TRANSFER**

Forbis Logistics will not share your personal data with third parties for any purpose other than that to which you have consented. Forbis Logistics may share your personal data with other companies and entities within the Ferreycorp corporation for the purposes to which you have consented. Forbis Logistics may also share your personal data with third parties located both within and outside the country, such as Google LLC, located at 1600 Amphitheatre Pkwy, Mountain View, CA 94043, United States, or other similar companies, but only under strictly limited circumstances, as indicated below:

We may provide your personal data to third parties (such as our internet service providers, website administrators and social media account managers, call centers, courier services, transportation providers, seminar or training providers, clients, etc.) who help us maintain and manage this or other Forbis Logistics sites and/or those of other companies and/or entities within the Ferreycorp corporation (including, but not limited to, Forbis Logistics' social media pages and accounts). These third parties may be located outside of the country.

We may also provide your personal data to public administration bodies and competent authorities if required to do so by law. In some cases, we must also provide your personal information to these entities for the purposes of conducting legal, judicial, and/or administrative proceedings; to respond to any claim or lawsuit; or to protect the legitimate rights of Ferreycorp companies and entities, its clients, and any other users.
